



Flirt Studios Terms and Conditions

1. Flirt Studios is the trading name of Flirt PR Ltd. From herein Flirt PR Ltd will be referred to as Flirt Studios for the remainder of this document.
2. Flirt Studios is available to hire Monday to Saturday 9am til 6pm at a rate of £25 per hour, evenings after 6pm and Sundays at £30 per hour and out of hours from 10pm til 7am at £60 per hour. Discounted rates are subject to availability and only if agreed prior to the booking in writing. All prices are exclusive of VAT.
3. 50% deposit is required at the time of booking to secure your time slot with Flirt Studios. All deposits are non-refundable and the remaining fee must be paid prior to arrival up front before your studio session begins.
4. Flirt Studios accept cash, bank transfer and card payments only (Visa, MasterCard, Switch, Maestro). Flirt Studios does not accept cheques or payment via PayPal.
5. Any cancellations made within 7 days of the booking 50% of the studio hire fee will be liable. Cancellations made within 3 days or less clients will be liable for the full amount.
6. All clients will be expected to provide their full name, address, contact number and email address prior to the booking. If booking on behalf of a business then the registered business name / address and registration number must be provided.
7. The client / business making the booking will be liable for the deposit and payments.
8. The client / business making the booking will be liable for any damages caused to the studio, equipment, furniture, studio lighting and / or any internal and external structural damage that was not present before the booking took place.
9. Flirt Studios staff will check the studio and equipment with the client both prior to the booking and once the studio booking is complete. Should the client leave before the checks have taken place they will be in breach of these terms.
10. Should an incident take place during a studio hire session, the booker will be required to pay for any damages before exiting the building. Should the person(s) liable refuse to pay for damages caused then local authorities will be called to the studio immediately without hesitation and necessary action taken.
11. The booker is required to leave the studio in the condition they entered. On arrival at Flirt Studios clients can expect a clean, tidy and welcoming studio environment; we require the studio to be vacated as such and will charge for any excess mess / tidying that Flirt Studios staff may incur should the studio not be left in a satisfactory state.
12. All studio hire fees include use of Flirt Studios photographic equipment, furniture, props and lighting facilities (Bowens), exclusive use of the ground floor, exclusive use of floor 1 and non-exclusive use of floor 2. For exclusive use of Floor 2 (TIW Combat Academy) there is an extra charge of £25 per hour in order for the academy to facilitate and vacate this floor.

13. If using Floor 2 (TIW Combat Academy) during a studio hire session no footwear of any kind is permitted inside the MMA Cage, Matted areas and Boxing Ring at any time. There will be an on the spot fee of £50 to any person(s) wearing footwear on any of TIW Combat Academy's equipment.
14. When booking Flirt Studios it must be stated in writing what usage the studio is being hired for ie: Photography, Model / Make Up tutorial, fitness / dance class, business meeting etc. If you are hiring the studio for photography usage please state prior to the booking what levels the model(s) are working to. Please note we have restrictions on some adult levels so please state clearly if shooting adult levels prior to booking to avoid any confusion on the day. Any adult levels would have to be agreed in writing prior to booking the studio.
15. Flirt Studios has a strict No Smoking policy. Anyone found smoking on the premises will be fined £500. No exceptions to this policy.
16. Should the above terms and conditions be breached Flirt Studios will not hesitate to take the necessary legal action to compensate for any loss, damage, and / or loss of earnings as a result of noncompliance for which the client will be held fully liable.

Health and Safety Procedures

1. Fire safety: Fire extinguishers are located throughout the building along with fire alarms and smoke detectors. Should the fire alarm go off please vacate the building immediately via the closest exit and inform a staff member if you have seen any evidence of a fire ie: smoke etc on your way out.
2. Should any client have any health and safety queries or special requirements please inform us prior to the booking. Flirt Studios will aim to adhere to all clients needs to the best of our ability and provide a safe and enjoyable working environment.

Amenities

1. Male and female toilets are located on the 1st floor along with the kitchen. Flirt Studios supply tea, coffee, hot chocolate and soft drinks free of charge to all clients and the studios are less than a minute walk away from high street retailers and food shops / supermarkets for refreshments.
